**3. HAZARDS IDENTIFICATION**

**Main hazards:** Irritating to eyes.

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be mild irritation at the site of contact.  
**Eye contact:** There may be irritation and pain.  
**Ingestion:** There may be irritation of the throat.  
**Inhalation:** There may be coughing and a sore throat.
